SALINE COUNTY QUORUM COURT MINUTES JANUARY 17, 2023

The Saline County Quorum Court met on Monday, January 17, 2023 at 6:30 p.m. in Courtroom #3 in the Saline County Courthouse. County Judge Matt Brumley called the meeting to order. Justice of the Peace Jim Whitley gave the invocation and Justice of the Peace C. J. Engel led the Pledge of Allegiance.

Roll call was taken with 10 members in attendance. Everett Hatcher, Rick Bellinger and Clint Chism were absent.

Motion by Justin Rue and seconded by Barbara Howell to approve the Minutes from the December 19, 2022 Quorum Court Meeting. Motion passed unanimously by voice vote.

REPORTS/PROCLAMATIONS:

Report of appointment of Jim Whitley as new Chairman of the HR Committee. He thanked the committee for their decision and faith in him.

OLD BUSINESS:

Motion by J. R. Walters and seconded by Barbara Howell to suspend the rules and read title only of Exhibits "A" through "F". Motion passed unanimously by voice vote.

Exhibit "A": Motion made by Pat Bisbee and seconded by Carlton Billingsley to approve the Third Reading of Ordinance Amending Ord. 92-36 for the purpose of Adding Roads to the County Road System. Roll call vote; motion passed unanimously. Ordinance 2023-1.

Exhibit "B": Motion by J. R. Walters and seconded by Carlton Billingsley to Approve an Ordinance Setting Rules of Procedure for the Saline County Quorum Court. Roll call vote; motion passed unanimously. Ordinance 2023-2.

Exhibit "F": Motion by Keith Keck and seconded by Jim Whitley to Approve Resolution Expressing the Willingness of Saline County to Utilize Arkansas Public Safety Communication Grant Program Funds – Saline County Radio Replacement Project. Motion passed unanimously by voice vote. Resolution 2023-2.

DISCUSSION:

In regard to Exhibit "F", C. J. Engel wanted to know what the total amount of funds were allotted for OEM. Josh Curtis said they were requesting \$400,000 and hoping for all.

COMMENTS:

A resident of Justice of the Peace District 10 asked who her JP was and what their contact information was. JP Jim Whitley, gave her his contact information. She also wanted to know how she could better access the county mapping system and website. Judge Matt Brumley explained that we are in the process of updating the website to offer more information and to make it more user friendly. He also gave her the phone number for the main office she could contact regarding additional information.

EMERGENCY ORDINANCE NO. 2023 - 5

BE IT ENACTED BY THE QUORUM COURT OF SALINE COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED: "AN ORDINANCE TO UPDATE AND AMEND EMERGENCY ORDINANCE NO. 2021-13, REGARDING AN ELECTRONIC FUNDS TRANSFER SYSTEM, AND FOR OTHER APPROVED WARRANTS DEEMED NECESSARY; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES."

- WHEREAS, Arkansas Code Annotated § 14-24-121(a) allows for the Quorum Court of each county to establish an electronic funds transfer system for payment of any account allowed against the county; and
- WHEREAS, Arkansas Code Annotated § 14-24-121(d) further stated that a single electronic funds transfer may contain payments to multiple payees, appropriations, characters, and funds; and
- WHEREAS, the Quorum Court passed Emergency Ordinance No. 2021-13 on May 17, 2021, establishing an electronic funds transfer system, as authorized by Arkansas Code Annotated § 14-24-121(b); and
- WHEREAS, the purpose of Emergency Ordinance No. 2021-13 was broad, seeking to reduce costs and increase efficiencies by authorizing electronic funds transfers for payroll direct deposits payroll taxes, Arkansas Public Employees Retirement System (APERS) benefits transfers, employee benefits payments, voluntary payroll products, Department of Finance and Administration (DFA) Sales and Use Tax payments, and any approved electronic funds transfers deemed necessary; and
- **WHEREAS**, to continue costs reductions and efficiency increases, the County Treasurer's Office, with the support of the Financial Management Office, plans to increase the scope of the County's electronic funds transfers beyond those addressed in Emergency Ordinance 2021-13,
- WHEREAS, the County's electronic funds transfers will include payments from the Saline County Treasurer's funds and accounts to, including but limited to, the State, school districts, municipalities, fire protection districts, improvement districts, and any other entities where approved electronic funds transfers are deemed necessary; and
- NOW, THEREFORE, BE IT ORDAINED by the Quorum Court of Saline County, Arkansas that:
- Article 1. That the County established an electronic payment system with Emergency Ordinance 2019-05, which provides for internal accounting controls and documentation for audit and accounting purposes.
- Article 2. That Saline County Emergency Ordinances 2019-05 and 2021-13 are hereby amended.
- **Article 3**. That all parts of Saline County Emergency Ordinance No. 2019-05 and 2021-13 that are in conflict with this Ordinance are hereby repealed.
- **Article 4**. That the Financial Management Office, with the support of the Treasurer's Office, is authorized to make electronic funds transfers for payroll direct deposits, payroll taxes, APERS benefits transfers, employee benefits payments, voluntary payroll payments, DFA Sales and Use Tax payments; and, payments from the Saline County Treasurer's funds and accounts to, including but not limited to, the State, school districts, municipalities, fire protection districts, improvement districts, and any other entities where approved electronic funds transfers are deemed necessary; and

- **Article 5.** That the county's electronic payment method and warrant transfer system was reviewed by Legislative Audit on December 3, 2015.
- **Article 6.** That the county's electronic funds transfer system complies with the information systems best practices and was approved by the Legislative Joint Auditing Committee on March 4, 2016, as per Arkansas Code Annotated §14-24-121.
- **Article 6**. If any provision of this Ordinance or the application thereof to any person or circumstance is held to be invalid, such invalidity shall not affect other provisions or applications and, to this end, the provisions of this Ordinance are declared severable.
- **Article 7.** As time is of the essence in ensuring that the County can continue to reduce costs and increase efficiencies, along with ensuring that the County's electronic funds transfers system is operational, an emergency is hereby declared to exist, and this ordinance shall be in full force and effect from and after its passage and approval.

APPROPRIATION ORDINANCE NO. 2023 - ____

BE IT ENACTED BY THE QUORUM COURT OF SALINE COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

"AN ORDINANCE TO AMEND THE 2022 SALINE COUNTY BUDGET ORDINANCE NO. 2021-31; ANTICIPATE REVENUE AND TO APPROPRIATE/TRANSFER FUNDS THEREFORE TO THE VARIOUS BUDGETS; AND, FOR OTHER PURPOSES."

WHEREAS, the County received several grants that required the County General Fund to front the money and be reimbursed at a later date. Such grants will reimburse the funds to the County General Fund upon the County receiving such reimbursement in FY 2023. The County Judge requests to appropriate additional funds in Fund 1000 – County General, Funding for Reimb Grants (0127) budget to cover these grant funds that were upfronted (Article 1); and,

WHEREAS, the Sheriff requests to transfer funds in Fund 1000 – County General Fund, Sheriff Department (0400) budget for Parts & Repairs line item expenditures (Article 2); and,

WHEREAS, the County Judge requests to appropriate funds in Fund 2000 – County Road Fund, Road Department (0200) budget for Capital Outlay – AHD & Construction project expenditures for the year 2022, related to the various Road Department projects and appropriate revenues received from various projects federal grants for 2022, received by the County Treasurer (Article 3); and,

WHEREAS, the Quorum Court approved Ordinance 2022-4 to transfer ARP funds related to Fund 1006 – ARP Revenue Replacement Fund, as allowed by the federal guidelines, the County Financial Management Department requests to appropriate funds in Fund 3046 – American Rescue Plan Fund (Article 4); and,

WHEREAS, the Airport Commission sold property in 2022 and created Fund 3416 – Saline County Airport Special Projects Fund with the proceeds, and a portion of those funds were expensed to upfront reimbursable expenses from various state and federal grants, the Airport Commission requests to appropriate funds in Fund 3416 – Saline County Airport Special Projects Fund budget (Article 5); and,

WHEREAS, the Airport Commission received a reimbursable State Grant and expensed funds from the Saline County Special Projects Fund to upfront the expenses, the Airport Commission requests to appropriate funds in Fund 3514 – Saline County State Grants Fund budget to reimburse such fund (Article 6); and,

WHEREAS, the Airport Commission received a Federal Grant in 2022, the Airport Commission requests to appropriate the grant fund expenses in Fund 3762 – Saline County Airport Federal Fund budget (Article 7); and,

WHEREAS, the year 2022 is the first year that Saline County Financial Management Department, along with the Airport Commission, has created a budget and maintained the finances of the Saline County Airport in the County financial management system. Several budget line items were under budgeted. The Airport Commission requests to appropriate additional funds in Fund 7001 – Saline County Airport Fund budget (Article 8); and,

WHEREAS, the Finance Committee previously met and approved this request.

NOW THEREFORE BE IT ORDAINED BY THE QUORUM COURT OF SALINE COUNTY, ARKANSAS:

<u>Article 1</u>. That the sum of \$152,719.00 is hereby appropriated in the County General Fund, Funding for Reimb. Grants (0127) Department budget as follows:

WHEREAS, the Sheriff's VOCA Victim Advocate Grant did not allow for the total increase for the employee paid by such grant for 2022-23 grant year. The Sheriff requests to appropriate an additional salary line to the Fund 1000 – County General, Sheriff Department (0400) budget to allow this employee to have the same level of pay as other deputies in the department (Article 1); and,

WHEREAS, the County Treasurer would like to update various equipment, update the office, and purchase additional supplies for the office. She requests to appropriate additional funds in Fund 3000 – Treasurer's Automation Fund of \$10,000 for the necessary updates (Article 2); and,

WHEREAS, the Saline County Airport Commission approved a ten percent (10%) increase for the Saline County Airport Manager for the 2023 budget year. SECTION II: The Saline County Quorum Court pledges its full support, including financial if necessary, for the SCEC conducting recounts, as contemplated by Ark. Code Ann. § 7-5-319(b), to ensure public confidence in Saline County elections.
